



## CITY OF SUISUN CITY LOCAL APPOINTMENTS LIST

In compliance with the requirements of Government Code 54970, on or before December 31 of each year, each legislative body shall prepare an appointments list of all regular and ongoing boards, commissions and committees which are appointed by the legislative body of the local agency. This list shall be known as the Local Appointments List. The list shall contain the following information: (a) A list of all appointive terms which will expire during the next calendar year, with the name of the incumbent appointee, the date of appointment, the date the term expires, and the necessary qualifications for the position; (b) A list of all boards, commissions and committees whose members serve at the pleasure of the legislative body, and the necessary qualifications for each position.

Suisun City commissions are composed of residents appointed by the City Council. Most of the actions taken by a commission are recommendations to the City Council for further consideration and action. All Commissioners must be residents of the City of Suisun City and possess a desire to serve the community.

Commissions serving the City Council are:

### Planning Commission

The Planning Commission meets at 7:00 p.m. on the second and fourth Tuesday of the month in the Council Chambers at Suisun City Hall. The Commission reviews and makes recommendations on the community's General Plan, development applications and policy proposals on both current development, as well as long range plans for future development.
