## NOTICE OF PUBLIC HEARING

### THE CITY COUNCIL OF THE CITY OF SUISUN CITY IS CONSIDERING THE ESTABLISHMENT OF A CANNABIS BUSINESS ZONE, DEVELOPMENT AGREEMENT AND COMMERCIAL CANNABIS BUSINESS PERMIT AT 300 RAILROAD AVENUE (0037-160-100).

**NOTICE IS HEREBY GIVEN THAT** the City Council of the City of Suisun City is conducting a public hearing considering the establishment of a Cannabis Business Zone (CBZ 21/22-001) and Development Agreement (DA 21/21-001) and consideration of a Commercial Cannabis Business Permit for a Type 10 Retail Cannabis Dispensary and Delivery at 300 Railroad Avenue, Suisun City, CA. The Planning Commission recommended project approval at their regular meeting of March 8, 2022, by a 5-0 vote.

This project is categorically exempt from the California Environmental Quality Act (CEQA), per Sections 15061(b)(3) and Section 15301, Existing Facilities, of the California Code of Regulations.

The City Council will consider this application at a Regular Meeting at **6:30 p.m., on Tuesday March 29, 2022**, at the Suisun City Council Chambers, 701 Civic Center Boulevard, Suisun City, California. All interested parties are invited to attend.
