NOTICE IS HEREBY GIVEN, pursuant to Section 54974 of the California Government Code, that one unscheduled vacancies has occurred on the Parks and Recreation Commission. The City of Suisun City is seeking applications from Suisun City residents interested in serving on the Parks and Recreation Commission.

PARKS & RECREATION COMMISSION

The Parks and Recreation Commission is an advisory board to the Recreation Department, Public Works Department and the City Council regarding all matters relating to the leisure services and activities conducted within Suisun City. The Parks and Recreation Commission meet the first and third Wednesday of each month at 7:00 p.m. Terms are for four years, unless the vacancy is due to an incumbent resigning mid-term. In that case, appointment is to the remainder of the unexpired term.

There is one (1) unscheduled vacancy with the term of office expiring January 2021.

Applicants must be residents of the City of Suisun City during their term of office. Interested residents may apply by submitting an application form to the City Clerk stating qualifications and objectives for desiring to be become a member of the Parks and Recreation Commission. Application forms are available at Suisun City Hall or at www.suisun.com. **Please submit applications as soon as possible, appointments may be made as early as May 1, 2018.**

Appointees must file a Statement of Economic Interests form with the City Clerk within thirty (30) days of assuming office, as mandated by California State Law.
