Approval of Minutes:

RPM Manager Hull stated that the 3 positions will be responsible for Entertainment; Marketing & Volunteer Recruitment; and Finance. After a brief discussion of the responsibilities of the coordinators,

  - Chairman Dubois volunteered to help coordinate Marketing and Finance. Commissioner Meek stated that she can also help Chairman Dubois with Marketing and Finance. Motion to approve by Commissioner Burket, seconded by Commissioner Risko, with a 7-0 vote.
