### E. PRESENTATIONS

### 1. Public Works Maintenance Update – Presented by RPMA Director Kris Lofthus

RPMA Director Kris Lofthus presented the Public Works Maintenance Department. Lofthus explained the maintenance challenges due to short staff and budget shortfalls. Lofthus also goes on to explain all that the Public Works Department does for the City, and all parks that are contracted out. This also includes any homeless encampments clean outs, center divides and walking paths throughout the City, street maintenance including lights and traffic signals, sewers, City streets, and other duties as needed such as for special events.

Chairperson Dubois asked about state level resources for the homeless encampments. RPMA Director Lofthus responded that there isn't for clean up, but we work with County when they're on County land, and the private landowners when they're on private land, in which we turn around and bill them for the clean up if they do not do it themselves.

Chairperson Dubois also asked about putting a Port-A-Potty instead of having to always cleaning up after the homeless, and RPMA Director

Lofthus expressed concern about giving them the idea they can stay and essentially having to "evict" them when we utilize the land. Commissioner Osborne and Commissioner Meek give Kudos to the Public Works Department for cleaning up.

   Chairperson Dubois pulled this item for discussion moved to General Business.

### G. GENERAL BUSINESS

## 1. Harbor Theatre Second Lease Agreement – Discussion & Approval

Chairperson Dubois asked why the Theatre group is asking for a two-year lease instead of a five year lease.

RPMA Director Lofthus gave an overview of the previous lease, and how the full-time staff that was there is no longer there due to discrepancies and other issues. Lofthus goes on to add that the volunteers are asking for a two-year extension. Lofthus also goes on to explain that the two-year lease is favorable for the City. Lofthus also adds that the Department is looking into e-games, twitch, and other platforms to bring to the Theatre as a program, and that there are some changes in the agreement that the Department is able to do that.

Commissioner Wilson also chimed in that e-sports is a huge area and is gaining more popularity.

Chairperson Dubois asked if Public Works or the Theatre group takes care of the maintenance.

RPMA Director Lofthus explained that the large ticket items for repair are on the City, but the Theatre group is responsible for the things that they need and/or want.

Commissioner Anderson asked if this lease covers the Lawler House. RPMA Director Lofthus replied that it does not, and that we are in the process of selling the Lawler House.

Commissioner Wilson asked if we should have a stipulation in the lease with the Theatre group regarding pandemic or lockdown clause.

RPMA Director Lofthus explained that yes, we will be adding that in to the lease, and that there is jargon that the City uses as a clause in the lease agreements.

Chairperson Dubois made a motion to accept the Lease Agreement as read.
