RPMA Director Lofthus went over the changes that the Art Ad Hoc wanted to bring back to the full Commission, reading over the proposed changes. Chairman Osborne asked if this would be retroactive, to which Director Lofthus replied that it would not.

5) Discussion and Recommendation to City Council – Public Arts Programs

Commissioner Washington is marked as attending the meeting – Washington came in during the accepting of the minutes.

RPMA Director Lofthus went over the proposed Public Art Programs – Sound Wall Art, Pop Up Art, and Basketball Backboard Art. The Sound Wall Art Program would be on the sound wall on HWY 12 between Marina Drive, and Village Drive, and would be 10 panels spread out along that portion of the sound wall(or other specified number); The Pop Up Art Program would mimic the Pop-Up Eggs from the VNA Gingy House's Easter event created from the RPMA Department and painted by the Distance Learning kids; The Basketball Backboard Art would be simply painted the back boards at basketball courts throughout Suisun City.

Vice-Chair Meek brought up the point that the sound wall art could be construed as graffiti depending on what was painted there, or murals that reflect the City's natural beauty, while Chairman Osborne brought up showcasing children's art, would be acceptable. Commissioner Washington is not fond of the sound wall art, and instead wants to focus smaller and more in the residential, to be more personal.

Commissioner Washington remarked that the sound wall art can be offensive to many people, and the mural can dirty up the City if not done correctly. Commissioner Meek agreed, and felt that the park benches idea, or the backboard idea, or the pop up art are great ideas, and much cheaper. Commissioner Risko agrees that focusing on the kids and having them participate in the art is a good idea.

Commissioner Meek suggested that the walkways and pathways are a great place to put art, because people find them and post them from their walks, so that other people can go find them. Chairman Osborne redirected to conversation to hopefully pass a motion to get any of the items motioned. Osborne suggested to the Commission that we want to move forward with the Pop Up Art and the Basketball Backboard Art.

Commissioner Wilson made the motion to move forward with the Pop Up Art and the Basketball Backboard Art Programs, with Commissioner Risko seconding. The motion is carried by the following vote:
