### XII.a Vote for CSBA Delegate Assembly for Subregion 3-C

Official election ballots for the 2020 California School Boards Association (CSBA) Delegate Assembly Representative to Subregion 3-C (Solano County) must be submitted by March 16, 2020. The Delegate Assembly fulfills a critical governance role within CSBA. Representatives meet twice each year and are tasked with setting CSBA's general policy direction. Delegates act as liaisons between CSBA and local board members in their regions, and they also meet with the other Delegates and the CSBA Director in their regions. Delegates serve two-year terms that begin April 1.
