City Manager Folsom presented an update on the monthly City Manager Newsletters, the city is currently going through labor negotiations, the importance of Measure S, and the current development projects.

Review and acceptance of the FY 2023-24 Proposed Budget – (Deol: <u>ldeol@suisun.com</u>).

Finance Director Deol discussed FY23 Measure S financial status and presented a presentation on FY 2023-24 Proposed Budget.

- Amended budgets total resources available were \$4.5 million dollars. Year to date until end of April this year so far, we've received total resources of \$2.4 million dollars.
- Sales tax usually lags 2-3 months behind due to quarterly payments.
- Projecting to collect \$3.8 million dollar sales tax projections.
- Operating expenditures: 4 police officer positions, 3 dispatchers, 3 code enforcement, fire marshal, fire division chief, 3 fire captain, 3 fire engineers, 1 computer technician.
- One time expenditures are rolling forward for street repair program for \$616,000 to next fiscal year, allocating \$10,000 for Sidewalk/ADA repairs to next year fiscal, \$225,000 for Public Safety Communication Systems that is an ongoing payment each year, as well as \$70,000 for Business Management Software, and \$215,000 for the SR12 Clean CA Grant to rollover to next year.

Committee Members Pisching, Peters and Forney asked clarifying questions.

Finance Director Deol and City Manager Folsom responded to questions.

Committee Member Pisching motioned for acceptance of the FY 2023-24 Proposed Budget and seconded by Committee Member Peters Motion passed by the following vote:
