PROPOSED SUISUN CITY HISTORIC WATERFRON BID FEE AMENDMENT FOR 2020 AND 2021

The committee of Laura Cole-Rowe, John Harter, Magda Nathan-Funk and Suisun City Manager Greg Folsom met on Monday, August 24, 2020 at 5 pm.

 The committee unanimously recommends that the BID fee for 2020 be waived – the board will need to approve this recommendation before it goes to city council for approval.

The committee discussed various fee schedules for the BID Zones and businesses, and have come up with the following recommendation for the SCHWBID for approval:

• Eliminate Zones A, B and C – there will only be one "zone" for BID Fees

Businesses would be assessed as follows:

Cannabis Businesses	\$1,000

Business type definitions:

Retail and restaurant: Businesses that buy and resell goods, examples are clothing stores, shoe stores, office supplies as well as businesses that sell prepared foods and drinks.

Service businesses: Businesses that sell services. Examples are repair shops, most automotiveoriented businesses, entertainment businesses such as theaters, etc. Beauty, nail salons, massage businesses and barber shops will be in another category.

Lodging: Includes renting rooms by the day or week to community visitors.

Professional businesses: Includes architects, engineers, attorneys, dentists, doctors, accountants, optometrists, realtors, insurance offices, mortgage brokers and most other businesses that require advanced and/or specialized licenses and/or advanced academic degrees.

Financial institutions: Includes banking and savings and loan institutions as well as credit unions, etc.

New categories:

Cannabis Businesses: Even though we do not have a cannabis business currently in the downtown district, we feel that this type of business would be willing to pay the fee. Cannabis businesses in other communities have been generous to their BIDs and PBID and often sponsor events and contribute to the association.

Beauty, nail salons, massage businesses and barber shops: Currently only the owner of the "shop" is paying BID fees even though independent contractors withing the shops hold a business license. We propose that all license holder pay an annual fee of \$25. There are an additional 32 business licenses that would be added for this.

Estimated income: With the reduced fees, addition of a new hotel, and the additional of 32 beauty operator licenses, we estimate the total amount of BID fees for 2021 would be \$11,875
