NOTICE OF PUBLIC HEARING OF THE CITY COUNCIL OF THE CITY OF SUISUN CITY CONSIDERING THE CRYSTAL SCHOOL/PARCEL 14 PLANNED UNIT DEVELOPMENT, PRECISE DEVELOPMENT PLAN AND VESTING TENTATIVE SUBDIVISION MAP, APN 0032-152-180

NOTICE IS HEREBY GIVEN THAT the City Council of the City of Suisun City is conducting a public hearing to consider the Crystal School/Parcel 14 Planned Unit Development (PUD), Precise Development Plan and Vesting Tentative Subdivision Map (VTSM) for property generally bounded by Cordelia Street, the Southern Pacific Co. rail yard, California Street and School Street. The proposed project includes 78 residential dwellings and associate public improvements.

Development of the project site was analyzed in the Environmental Impact Report was prepared for the General Plan (SCH# 2011102046) and it has been determined that no further environmental review under the California Environmental Quality Act (CEQA) is required or appropriate subject to CEQA Guidelines Section 15183.

The Planning Commission, at a public hearing of May 23, voted 5-1-1 recommending City Council denial of the development application.

The City Council will hold a public hearing to consider the item at a regular meeting on **Tuesday, June 13, 2017 at 7:00 p.m.** at the Suisun City Council Chambers, 701 Civic Center Boulevard, Suisun City, California. All interested parties are invited to attend.

The original application is on file and may be reviewed at the Suisun City Development Services Department at 701 Civic Center Boulevard between 8:00 a.m. and 6:00 p.m., Mondays, Wednesdays and Thursdays and between 8:00 a.m. and 7:00 p.m. on Tuesdays, City Hall is closed on Fridays.
