MEETING DATE: January 6, 2015

CITY AGENDA ITEM: Regulation of Smoking at Special Events:

- a. Council Adoption of Ordinance No. 730: Amending Title 12, Chapter 12.12 of the Suisun City Code Regulating the Smoking of Tobacco Products during Special Events in Parks and Recreational Areas; and
- b. Council Adoption of Resolution No. 2015-__: Designating Certain Open Spaces as Parks and Recreational Areas and Identifying which Are Subject to the Smoking Ordnance.

FISCAL IMPACT: There would be no fiscal impacts to the General Fund to amend the ordinance adding sections 12.12.005, 12.12.080, and 12.12.085. There may be a slight increase in revenue to the General Fund in issuing citations for the infractions.

BACKGROUND: On July 15, 2014, staff brought to Council a Discussion and Direction Local Land Use item regarding smoking of hookah and e-cigarettes and the dangers of their use in public places. The Council directed staff to come back with a discussion and direction item on regulating the use of tobacco in public places such as parks and the downtown plaza during events sponsored by the City and that of the Suisun City Historic Waterfront Business Improvement District.

On October 7, 2014, staff brought the item back to the Council for discussion and direction. The City Council directed staff to present the Council with an ordinance that will be unique to Suisun City in restricting smoking at special events open to the general public in the Marina Plaza area and within the event boundaries only at any City Park.

On December 16, 2014, the City Council opened a public hearing on the proposed ordinance, but ended up continuing the item to January 6, 2015, due to concerns about the designation of certain areas as parks or recreational areas. This item focusses solely on the smoking ordinance. The actual designation of the specific sites that the ordinance will apply to would occur on January 20, 2015, when the ordinance is adopted. At that time the City Council may adopt a resolution which specifies those sites.

On January 6, 2015, the City Council introduced Ordinance No. 730, which would ban smoking in designated locations during special events open to the public. The Council also indicated acceptance of the list of locations provided by staff.

STAFF REPORT: Staff reviewed the Suisun City Code to determine the best location to address the Council's interest. It was determined that Title 12, Section 12.12 – Parks and Recreational Facilities would be the most appropriate. The proposed ordinance would prohibit smoking during Special Events open to the public in Parks and Recreational areas, including the Suisun City Marina area. After enactment off this ordinance, should the Council be desirous of changing which facilities are designated as non-smoking during Special Events open to the public, such changes could be accomplished via resolution.

A resolution has been prepared which would declare all of those locations that the Council wishes to designate as subject to the smoking restrictions. The proposed resolution would also provide clarification as to what open space areas are considered Parks or Recreational Areas. The resolution may be amended by the Council in any subsequent resolution to add, or delete from the list.

RECOMMENDATION: It is recommended that the City Council:

- 1. Adopt Ordinance No. 730: Amending Title 12, Chapter 12.12 of the Suisun City Code Regulating the Smoking of Tobacco Products during Special Events in Parks and Recreational Areas and the City Marina Area; and
- 2. Adopt Resolution No. 2015-__: Designating Certain Open Spaces as Parks and Recreational Areas and Identifying which Are Subject to the Smoking Ordnance.

ORDINANCE NO. 730

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SUISUN CITY, CALIFORNIA, AMENDING TITLE 12, CHAPTER 12.12 OF THE SUISUN CITY CODE REGULATING THE SMOKING OF TOBACCO PRODUCTS DURING SPECIAL EVENTS IN PARKS AND RECREATIONAL AREAS

WHEREAS, the City is concerned that secondhand smoke and litter during Special Events in Parks and Recreational Areas detracts from the overall enjoyment of Special Events open to the public; and

WHEREAS, tobacco use causes death and disease and continues to be an urgent public health challenge, as evidenced by the following:

- Approximately 480,000 people die in the United States from tobacco-related diseases every year, making tobacco use the nation's leading cause of preventable death; and
- Tobacco use can cause disease in nearly all organ systems and is responsible for 87% of lung cancer deaths, 32% of coronary heart disease deaths, 79% of chronic obstructive pulmonary disease, and third of all cancer deaths; and
- Some of the most common types of cancers including stomach, liver, uterine, cervix, and kidney are related to tobacco use; and

WHEREAS, secondhand smoke has been repeatedly identified as a health hazard, as evidenced by the following:

- The U.S. Surgeon General concluded that there is no risk-free level of exposure to secondhand smoke and separating smokers from nonsmokers, cleaning the air, and ventilating buildings cannot eliminate exposures of nonsmokers to secondhand smoke; and
- The California Air Resources Board placed secondhand smoke in the same category as the most toxic automotive and industrial air pollutants by categorizing it as a toxic air contaminant for which there is no safe level of exposure (California Health and Safety Code 39650 et seq.); and
- The California Environmental Protection Agency included secondhand smoke on the Proposition 65 list of chemicals known to the state of California to cause cancer, birth defects, and other reproductive harm; and

WHEREAS, exposure to secondhand smoke causes death and disease, as evidenced by the following:

- Secondhand smoke is responsible for an estimated 50,000 deaths among nonsmokers each year in the United States; and
- Exposure to secondhand smoke increases the risk of coronary heart disease by about 25% to 30%" and increases the risk of stroke by 20% to 30%. Secondhand smoke exposure causes lower respiratory tract infections, such as pneumonia and bronchitis, in as many as 300,000 children in the United States under the age of 18 months each year and exacerbates childhood asthma; and

WHEREAS, tobacco use and exposure to secondhand smoke impose great social and economic costs, as evidenced by the following:

- Between 2009 and 2012, the total annual economic burden of smoking in the United States was between \$289 billion and \$332.5 billion; and
- From 2005–2009, the average annual health care expenditures attributable to smoking were approximately \$132.5 billion to \$175.9 billion in direct medical care costs for adults and \$151 billion in lost productivity; and
- The medical and other costs to nonsmokers due to exposure to secondhand smoke were estimated at over \$10 billion per year in the United States in 2005; and
- The total annual cost of smoking in California was estimated at \$548 per resident or between \$2,262 and \$2,904 per smoker per year; and
- California's Tobacco Control Program saved the state and its residents \$134 billion in health care expenditures between the year of its inception, 1989, and 2008, with savings growing yearly; and

WHEREAS, exposure to secondhand smoke anywhere has negative health impacts, and exposure to secondhand smoke does occur at significant levels outdoors, as evidenced by the following:

- Levels of secondhand smoke exposure outdoors can reach levels attained indoors depending on direction and amount of wind and number and proximity of smokers; and
- Irritation from secondhand smoke begins at levels as low as 4 micrograms per cubic meter, and in some outdoor situations this level can be found as far away as 13 feet from the burning cigarette; and
- Smoking cigarettes near building entryways can increase air pollution levels by more than two times as compared with background levels, with maximum levels reaching the "hazardous" range on the U.S. EPA's Air Quality Index; and
- To be completely free from exposure to secondhand smoke in outdoor places, a person may have to move nearly 23 feet away from the source of the smoke, about the width of a two-lane road; and

WHEREAS, cigarette butts pose a health threat to young children, as evidenced by the following:

- In 2012, American poison control centers received nearly 8,648 reports of poisoning by the ingestion of cigarettes, cigarette butts, and other tobacco products and 84.5% of these poisonings were in children age 5 and younger; and
- Children who ingest cigarette butts can experience vomiting, nausea, lethargy, and gagging; and

WHEREAS, cigarette butts are a major and persistent source of litter, as evidenced by the following:

- In 2007, it was estimated that Americans consume 360 billion cigarettes each year; and
- 55.7% of smokers admit to littering cigarettes in the last month; and
- In an observational study of 9,757 individuals, after cigarettes were smoked, 45% of cigarettes ended up as litter; and
- In 2011, 22.6% of all debris collected from beaches and coastal areas are smoking related products; and
- Cigarette butts are often cast onto sidewalks and streets, and frequently end up in storm drains that flow into streams, rivers, bays, lagoons, and ultimately the ocean; and
- These discarded cigarette butts have been found to adversely impact the health of both pets and wildlife; and
- Cigarette filters, made of plastic cellulose acetate, can take up to several years to degrade; and

WHEREAS, laws restricting the use of tobacco products have recognizable benefits to public health and medical costs, as evidenced by the following:

- Cities with smoke-free laws see an appreciable reduction in hospital admittances for heart attacks in the months and years after such laws are passed; and
- Smoking bans help people reduce the number of cigarettes they smoke or quit altogether; and
- Strong smoking regulations for restaurants decrease the number of children who transition from experimenting with smoking to becoming actual smokers; and

WHEREAS, while smokers would be restricted from smoking during Special Events open to the public during the period of the event, they would not be restricted from smoking in areas where smoking is permitted outside of the Special Event boundaries.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SUISUN CITY, CALIFORNIA, DOES ORDAIN AS FOLLOWS:

SECTION 1.

Title 12, Chapter 12.12 of the Suisun City Code relating to the Use of Parks and Recreational Facilities is hereby amended as follows:

AMENDING TITLE 12, CHAPTER 12.12 – "SMOKING AT SPECIAL EVENTS"

12.12.005 - Definitions.

The following words and phrases, as used in this Chapter, are defined as follows:

- "Park" is defined as any open space designated as such by resolution of the City Council.
- В. "Recreational Area" is defined as any open space designated as such by resolution of the City Council.
- "Smoke" means the gases, or particles released into the air as a result of combustion, when the apparent or usual purpose of the combustion is human inhalation of the byproducts, except when the combusting or vaporizing material contains no tobacco or nicotine and the purpose of inhalation is solely olfactory, such as, for example, smoke from incense. The term "Smoke" includes, but is not limited to, tobacco smoke, marijuana smoke, and crack cocaine smoke.
- D. "Smoking" means engaging in an act that generates Smoke, such as, for example: possessing a lighted pipe, a lighted hookah pipe, a lighted cigar, or a lighted cigarette of any kind; or lighting or igniting a pipe, a hookah pipe, a cigar, or a cigarette of any kind.
 - "Special Event" is defined as a planned occasion or activity (such as a social gathering) sponsored by the City or any other public or private entity or organization, which is open to the public.
 - "Suisun City Marina" shall mean the land area as defined in Chapter 21, Section 21.10.010 of the Suisun City Code including all real property from the foot of the shoreline protection to the exterior of the landscape areas bordered generally by west curb of Civic Center Boulevard to the east, the south easement of State Route 12 to the north, the west sidewalk of Main Street, the south curb of Morgan Street and the west curb of Kellogg Street, to the west. This area includes all parks, wetlands, city hall, the public promenade, parking lots, the rail station and plaza, as well as all other marina-related property controlled by the City. Diagram A found in Section 21.10.010 depicts the Suisun City Marina.
 - "Toxic Air Contaminant" is defined as an air pollutant, identified in regulation by the California Air Resources Board (CARB) and California Health and Safety Code section 39650 et seq., which may cause or contribute to an increase in deaths or in serious illness, or which may pose a present or potential hazard to human health.

12.12.080 - Smoking Tobacco During Special Events.

Except as authorized by City permit or license, no person shall smoke any tobacco product emitting second-hand smoke, which is a Toxic Air Contaminant as defined by the California Air Resources Board, in the Suisun City Marina area during a Special Event open to the public, or at any City Park or Recreational Area during a Special Event open to the public within the specific event boundary. Any person violating any of the provisions or failing to comply with any of the mandatory requirements of this ordinance of the City is guilty of an infraction. Any person convicted of an infraction for violation of an ordinance of the City is punishable by:

Fine not exceeding fifty dollars for a first violation.

SECTION 2. EFFECTIVE DATE.

In accordance with Section 36937 of the Government Code of the State of California, this Ordinance shall take effect and be in force thirty (30) days from and after the date of its passage.

SECTION 3.

If any section, subsection, sentence, clause, or phrase of this ordinance is for any reason held to be invalid or unconstitutional by a decision of any court of any competent jurisdiction, such decision shall not affect the validity of the remaining portions of this ordinance. The City Council hereby declares that it would have passed this ordinance, and each and every section, subsection, sentence, clause, and phrase thereof not declared invalid or unconstitutional without regard to whether any portion of the ordinance would be subsequently declared invalid or unconstitutional.

SECTION 4.

This ordinance shall be posted in at least three (3) public places within the City or published in a county newspaper that is circulated in the City within fifteen (15) days after its passage, there being no newspaper of general circulation printed and published within the City.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SUISUN CITY DESIGNATING CERTAIN OPEN SPACES AS PARKS AND RECREATIONAL AREAS

WHEREAS, Section 18.38.010 of the Suisun City Code designates parks in the "P" zone which defines parks as four acres or larger; and

WHEREAS, this designation only encompasses seven parks in the City as four acres or more; and

WHEREAS, the designation excludes eight other parks, because they are fewer than four acres; and

WHEREAS, Chapter 12.24 of the Suisun City Code prohibits camping or the storage of camping equipment in City parks; and

WHEREAS, the definition of "Park" in Section 12.24.020 of the Suisun City Code does not clearly identify all Parks and Recreational Areas; and

WHEREAS, Chapter 12.12 of the Suisun City Code provides that the City Council may define by Resolution those Parks and Recreational areas which are subject to non-smoking during Special Events open to the public; and

WHEREAS, it is the City's interest to simplify the Suisun City Code by identifying all the Parks and Recreational Areas, regardless of their size.

NOW, THEREFORE, BE IT RESOLVED that the City Council hereby defines Parks as those City facilities identified in Exhibit I, and Recreational Areas as those City facilities identified in Exhibit II.

BE IT FURTHER RESOLVED that Exhibit III designates those Parks and Recreational Ares that are subject to the provisions of Chapter 12.12 – Smoking Tobacco during Special Events.

- 8. PETERSEN RANCH LINEAR PARK 6.2 acres eastern boundary of Peterson Ranch development, walkway, lighting, benches and turf.
- 9. PUPLIC PROMENADE The public Promenade is the improved sidewalk that borders and encompasses the marina water's edge within the defined marina land area.

FISCAL IMPACT: Failure to approve the proposed resolution could result in the loss of approximately \$60,000 to fund the 2016 Fourth of July Celebration, as well as \$25,000 to enforce the sale of Safe and Sane fireworks.

BACKGROUND: This is an annual resolution to regulate the sales of Safe and Sane Fireworks. Specifically, certain dates, times, are required to be specified in a City Council Resolution.

In 2013, Title 8, Chapter 8.04 of the Suisun City Code was modified to ensure that future Safe and Sane fireworks sales periods may be approved by resolution without the need for technical changes every year to the City Ordinance.

STAFF REPORT: That attached Resolution provides the applicable dates for applying the Fireworks Ordinance to the 2015 Season. The following changes include the following:

- The due date for accepting applications will be February 5, 2015.
- The date for the lottery will be February 19, 2015, at 10:00 am.
- The date for execution of the fireworks wholesaler distribution agreement will be May 5, 2015.
- The date for submission of the public education plan will be May 28, 2015.
- Permissible hours of use. It shall be unlawful to discharge any "Safe and Sane Fireworks" except during the hours of 9:00 am to 10:00 pm June 28 through July 5.
- All unsold fireworks and accompanying litter shall be cleared from the location by 5:00 pm two (2) days after the fireworks sales period ends, (July 7). (Extended one day because of the weekend.)

These changes are proposed to be made to accommodate calendar changes in 2015 and a wholesaler request to move the lottery date so they could attend.

STAFF RECOMMENDATION: It is recommended that the City Council adopt Resolution No. 2015-___: Adopting Certain Findings and the Policy Directives to Implement the Sales and Use of Safe and Sane Fireworks for 2015 as Allowed by Chapter 8.04 of the Suisun City Code.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SUISUN CITY ADOPTING CERTAIN FINDINGS AND THE POLICY DIRECTIVES TO IMPLEMENT THE SALES AND USE OF SAFE AND SANE FIREWORKS FOR 2015 AS ALLOWED BY CHAPTER 8.04 OF THE SUISUN CITY CODE

WHEREAS, the Suisun City Code has been amended to permit the sales of Safe and Sane Fireworks, and to regulate other fireworks-related activities; and

WHEREAS, the sale of Safe and Sane Fireworks has benefitted the City of Suisun City by providing local Nonprofit Organizations who work for the benefit of the community with an opportunity to raise funds; and

WHEREAS, the City Council deems it necessary to adopt Certain Findings for the sale and use of Safe and Sane Fireworks; and

WHEREAS, the City Council deems it necessary to adopt Policy Directives for the sales and use of Safe and Sane Fireworks.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Suisun City hereby finds that Fireworks stands are categorically exempt from the California Environmental Quality Act ("CEQA") under CEQA Guidelines section 15311 as minor accessory structures appurtenant to existing commercial, industrial, or institutional facilities; and

BE IT FURTHER RESOLVED that the City Council of the City of Suisun City hereby adopts the following Policy Directives:

- 1. Number of permits. Three (3) Fireworks Sales Permits will be made available for the sale of Safe and Sane Fireworks in the City of Suisun City.
- 2. Locations of fireworks stands. Fireworks stand locations will be approved by the City Manager.
- 3. Fireworks stands. Fireworks stands may be put in place by the permittee no earlier than 8:00 a.m. on June 21.

Signs for fireworks sales shall be displayed no earlier than seven days (June 21) before the approved start of sales, June 28, and must be removed four (4) days after the fireworks sales period ends. (July 8)

All unsold fireworks and accompanying litter shall be cleared from the location by 5:00 p.m. two (3) days after the fireworks sales period ends, (July 7).

The fireworks stand shall be removed from the temporary location by 12:00 p.m. on July 10.

4. Permissible hours of use. It shall be unlawful to discharge any "Safe and Sane Fireworks" except during the hours of 9:00 am to 10:00 pm June 28 through July 5.

5. Permissible hours of sale. Dates and Hours of the sale of "Safe and Sane Fireworks" shall begin no earlier than 12:00 noon on June 28 and shall not continue after 9:00 pm on July 4 of the same year. Sale of fireworks shall be permitted only from 12:00 noon to 9:00 pm on June 28 and from 9:00 am to 9:00 pm daily June 29 through July 3, and 9:00 am to 9:00 pm on July 4.

· ...

- 6. Filing Application for Firework sales on July 4th. Applications will be accepted from January 1, until February 5, 2015, until 5:00 pm.
- 7. Permittee selection process. The process for selection of permittees to hold and use Fireworks Sales Permits shall be consistent with the following policy directives:
 - a. Only Qualified Applicants, as that term is defined in section 8.04.010 of the Municipal Code, shall be eligible to submit an application for a permit. Applicants are qualified on the basis of the following criteria:
 - i. Organizations that have proved they are qualified by documentation of charitable nonprofit status with the State and IRS 501 3c. The organization bylaws or Articles of incorporation shall state organized for a charitable, educational, religious, or scientific purposes, and, a nonprofit organization.
 - ii. Charitable organizations "Primarily Serving Suisun City Residents and Businesses," as that phrase is defined in the Municipal Code, and are organized primarily to benefit youth, schools, veterans, or local businesses in Suisun City shall be given preference in the first lottery drawing.
 - iii. The organization has at least 10 members that will staff the booth and a plan to keep the booth open for the full sales period.
 - iv. Organizations with less than 10 members shall produce an agreement with another nonprofit organization for a joint application.
 - b. The lottery shall take place at a time, place, and manner determined by the Fire Chief in accordance with the administrative rules and procedures adopted by the Fire Chief. In 2015, the lottery will be held on February 19, 2015, at 10:00 am in the Council Chambers.
 - i. If three or less organizations with the above preference apply, these organizations will be drawn in a lottery to determine selection for available permits.
 - ii. The choice of fireworks stand sites will be drawn separately after the permits have been determined.
 - c. After the authorized number of permits has been awarded, the remaining qualified applicants shall be drawn in a second lottery as alternates. Each alternate, according to the order drawn, shall be offered a permit if one of the original permittees cannot meet the requirements of this Chapter or if a permittee voluntarily surrenders its permit.

- 8. Fireworks Wholesaler—Distribution agreement.
 - a. All fireworks wholesalers who seek to do business in the city and supply and contract with applicants for fireworks booth permits in the city shall enter into and execute a fireworks wholesaler distribution agreement with the city no later than May 5, 2015.
- 9. Fireworks Wholesaler Public Education Plan.
 - a. Each fireworks distributor/wholesaler supplying one or more nonprofit organizations who are permittees under this chapter, shall submit a public education plan to the city by no later than 5:00 pm on May 28, 2015.
- 7. City Manager to administer fireworks program. The City Manager is hereby directed to administer the Suisun City Fireworks Program. The City Council of the City of Suisun City authorizes the City Manager to execute any and all necessary documents pertaining to implementation of the Sales and the Use of Safe and Sane Fireworks in the City Suisun City.

CITY AGENDA ITEM: Council Adoption of Resolution No. 2015-__: Authorizing the City Manager to Execute a Professional Services Agreement on the City's behalf with Pacific Municipal Consultants (PMC) for Planning Services.

FISCAL IMPACT: The contract to provide planning services through the remainder of this fiscal year would not exceed \$50,000, and will be billed on a time-and-materials basis (similar to the City Attorney contract). This would be funded from salary savings associated with the vacant Community Development Director position. No budget increase would be necessary.

BACKGROUND: In May 2014, the Community Development Director position became vacant and in November, a reorganization combining the Economic Development, Planning, and Housing Divisions into the Development Services Department took place. As part of the reorganization, it was anticipated that higher level planning support would be needed similar to the contract City Engineer position in the Building and Public Works Department, and that additional operational needs of the Planning Division would be monitored and adjusted accordingly depending on volume of work.

STAFF REPORT: A Request for Qualifications for planning services was published on December 16, 2014. Eleven proposals were received by the January 8, 2015 deadline. After review, the top six qualified firms were invited to participate in a formal interview process. The six firms interviewed were:

- Pacific Municipal Consultants (PMC)
- Raney Planning and Management
- Urban Planning Partners, Inc.
- MIG, Inc.
- Stevenson, Porto & Pierce, Inc.
- The M-Group, Inc.

PMC has proposed to provide Paul Junker as the primary candidate for this assignment. Mr. Junker is able to provide director level oversight of the City's planning operations, as well as project specific support as he is winding down a 10-year assignment as the Community Development Director in the City of Rancho Cordova and has over two decades of broad-based planning experience within municipal government. Providing staffing solutions to municipalities is a core business of PMC, and it has the ability to scale its staffing to meet the needs of Suisun City (Mr. Junker would assign tasks as necessary to the most qualified associates within the firm).

The ability of PMC to scale its staffing, as well as its ability to provide a qualified executive level planner that has capacity to work directly with City staff (not simply administer the contract to farm out work to junior level staff) are primary factors behind the recommendation to move forward with PMC. Mr. Junker would work under the supervision of the Development Services Director, and it is anticipated Mr. Junker would be at City Hall at least one day a week until such time that he has an understanding of the Department, the planning projects in the pipeline, and the overall needs of the City. This may change as workload changes. The City would be free to terminate the agreement at any time with a 30-day notice, and the needs beyond June 30, 2015, would be assessed as part of the FY 2015-16 budget process.

RECOMMENDATION: It is recommended that the City Council adopt Resolution No. 2015—: Authorizing the City Manager to Execute a Professional Services Agreement on the City's behalf with Pacific Municipal Consultants (PMC) for Planning Services.

However, staff has investigated lease-purchase options, and anticipates recommending a substantial down payment from the Vehicle Replacement Fund, with the remaining balance of financed through a lease-purchase arrangement. Payment is not required until 30 days after delivery of the engine.

BACKGROUND: The Fire Department currently has two Type 1 fire engines and a 100' ladder truck in service. Overall the fire fleet is aging and in need of a comprehensive strategy to address long-term equipment needs of the Fire Department, which will be addressed through the upcoming budget process.

In June 2014, three of the four main fire apparatus were down for repairs at the same time. Engine No. 3 is now out of service for good; as the transmission needs to be replaced at a cost of about \$20,000-\$25,000 with a rebuilt transmission. New parts are no longer available. It is estimated that the repair would not be prudent considering the age of the vehicle.

Engine 2 is also nearing the end of its service life as repair maintenance on this apparatus continues to become more common and costly. Parts are becoming harder to find, but the Fire Department is working hard to keep Engine 2 in good working order to safely serve its purpose. Engines that are constantly in disrepair cause morale issues with the firefighters. The situations faced by firefighters can often place them in dangerous, compromising positions, and the equipment used by the firefighters must not fail. For instance, when inside a building fighting fire, the water supply to the hoses is the single biggest safety factor for a firefighter. If the engine stops pumping water, the crews are place in greater, if not fatal, danger. Thus, it is recommended to purchase a Type 1 engine in order for the Fire Department to operate in a safe and more efficient manner.

O'Brien, Fire Chief Suzanne Bragdon, City Manager It should be noted that in 2013, the department achieved an ISO insurance rating of a Class 3 fire department (the same rating Fairfield and Vacaville have) based in part on the ability to pump 4,000 gallons a minute for a commercial fire. Engine No. 3 supplied 1,500 gpm of that total. The ISO rating is used as part of the determining factors used when calculating rates for most commercial fire insurance policies in our community. Failure to replace the pumping capacity of Engine No. 3 would result in the loss of the ISO Class 3 rating. This would have a negative impact on insurance rates, particularly for commercial properties in Suisun City.

Hi-Tech fire apparatus is the manufacturer recommended for the new engine in part, because its manufacturing facility and major repair facility is located in Oakdale, California. The purchase would be a "piggy back" on an active City of Tracy bid, so the City would not need to go through the time and expense of a bidding process.

STAFF REPORT: Based on the operational needs of the Fire Department, it is recommended the Fire Department be authorized to purchase a Type 1 fire engine. A type 1 engine and its crew is expected to handle structure and wildland fires, medical emergencies, traffic accidents, and other emergencies. A type 1 designation for a fire engine is based on minimum standards set by the National Incident Management System and California FIRESCOPE that is part of the Governor's Office of Emergency Services. The Type 1 engine has a minimum pumping capacity of 1000 GPM at 150 PSI, 300 gallons of water, 1200' of 2 ½" and 4" hose, 500' of 1 ½" hose, 48' of ladders (24'extension, 14' roof, and 10' attic), a 500 GPM Master stream device, and seats a crew of 4. The Insurance Services Office also requires other loose equipment. The engine we will purchase meets this standard and will have the space to carry large diameter 900' 4" supply hose, Medical equipment, Automatic Electronic Defibrillator, extrication jaws and cutter, and power and hand tools.

To save time and expense, the department talked to several other departments to evaluate their recent purchases of Type 1 engines. We found that the following cities have purchased from Hi-Tech recently: Fairfield, American Canyon, Marin County, San Francisco, Rodeo-Hercules, Santa Clara, Richmond, Davis, and San Jose. Hi-Tech prices are very competitive with the other large fire apparatus manufacturing companies. Hi-Tech also has the decided advantage of being the only company located in California. This means delivery from the factory and more importantly major repair work after purchase can be made at the factory in Oakdale, California. The other large companies are located in the East (Wisconsin, Florida, and Louisiana).

Currently Hi-Tech has an open bid for a Type 1 engine with the City of Tracy, which the City may "piggy back" on to under state law. The City was able to take advantage of the expertise provided by Captain Ken Forkes, who has worked on several engine specification documents with Hi-Tech for engines purchased by Novato. The proposal was signed on condition of the Council acceptance in order to lock in the 2014 price; the 2015 pricing increases the cost by \$65,000. The apparatus cost is \$497,822.80, with sales tax of \$37,958.99 for a total cost of \$535,781.79. This engine is designed to comply with the latest National Fire Protection Standards 1901, as well as the California clean air requirements. The engine will have a Cummins 380 HP diesel motor, a 1500 gpm pump, and seating for five. Delivery of the engine is anticipated in late 2015 or early 2016. Payment is due within 30 days of the delivery. However, if the City pays for the chassis (approximately \$200,000) upon delivery to the manufacturer which is anticipated in May or June of this year, a rebate of \$2,500 would be deducted from the total cost.

As previously mentioned, there are funds available in the Vehicle Acquisition Fund to pay for the engine; however at this time, staff would recommend a cash payment of \$235,000 from the Vehicle Acquisition Fund be utilized to purchase the engine, with the remaining acquisition cost of approximately \$301,000 financed through a lease-purchase program. Staff solicited proposals to determine current parameters of lease-purchase financing programs. For five-year lease terms, annual interest rates range between 1.78% and 2.54%, while for seven-year lease terms, annual interest rates range between 2.04% and 2.74%. All lease-purchase programs provide the City with ownership of the engine at the termination of the lease or with an option to purchase the engine at the end of the lease for \$1. Lease terms can be locked 30 to 60 days in advance of funding. Staff will analyze the financing options and also determine if paying for the chassis prior to its delivery to Hi-Tech in exchange for the \$2,500 rebate makes sense based on the financing alternatives available when the funds are due. This is the same approach that was used to acquire the department's 100' ladder truck.

STAFF RECOMMENDATION: It is recommended that the City Council adopt Resolution No. 2015-____: Authorizing the Commencement of the Purchase Process of a Hi-Tech Type 1 Fire Engine from Hi-Tech Fire Apparatus in Oakdale, California, and Authorize the City Manager to Execute All Documents Needed to Order the Apparatus and to Return to the City Council with Financing Options Prior to Acquiring the Apparatus.

- a. Council Adoption of Resolution No. 2015-_____: Authorizing the City Manager to Enter into

FISCAL IMPACT: There would be no impact to the General Fund. A total of \$574,000 has been appropriated for improvements to Walters Road in the FY 2014-15 Budget. The first phase of this work was the award of a contract for the Walters Road and Pintail Drive Rehabilitation Project. After expenses paid out for Phase 1, about \$100,000 remains for additional work. It is recommended that an additional \$220,000 be appropriated from Off-Site Street Improvement (OSSIP) funds to complete Walters Road Pavement Repair Project - Phase 2 plus additional paving repair and landscaping.

BACKGROUND: A total of \$574,000 has been budgeted from multiple sources for the rehabilitation of Walters Road. These include One Bay Area Grant (OBAG) Surface Transportation Program (STP) funds (\$356,000), funds specified for Walters Road capital improvements (\$160,500), funds from FSSD (\$6,500), and OSSIP funds (\$51,000). No General Fund money was being used. On August 19, 2014 a contract was awarded by the City Council to MCK Services for Phase 1. Phase 1 included asphalt rehabilitation from Peterson Road to Bella Vista Drive. After expenses to date there is \$100,000 remaining for additional work.

STAFF REPORT: Walters Road is one of the primary traffic corridors within our City. Traffic is expected to increase with the opening of Walmart. Phase 1 repaired structural problems in the asphalt from Petersen Road to Bella Vista Drive and also included an overlay from the Walters Road/Petersen Road intersection to Mammoth Way. The work to repair the same issues in the segment from Petersen Road to Highway 12 was not included in Phase 1, because of possible conflicts with the Walmart construction. The Walmart construction is nearing completion and there is a small window of opportunity to complete additional street work before the store opens. In general, Phase 2 would provide for roadway rehabilitation of a portion of Walters Road between Petersen Road and Highway 12. No overlay of this area is included.

Bids for this Project were opened on January 29, 2015, at 10:00AM at which time five bids were received and read aloud. Staff has reviewed the low bidder's proposal and bid documents. Staff has determined that the bid submitted by MCK Services is a responsive and responsible bid.

In light of the current budget, only repairs of the north bound lanes were included in the bid documents that were advertised. Those lanes are in the worse condition. Therefore the bid results shown above only include the northbound lanes. However, there are also significant needs in the south bound lanes. The low bidder has agreed to extend the same unit costs to the areas in the south bound lanes.

During the work of Phase 1 it was recognized that the trees in the center median were at the end of their useful life, plus low-hanging branches could pose a possible hazard to trucks. In addition, many of the roots had to be severely pruned to prevent recurring asphalt heaving, which caused further damage to the trees. Phase 3 of the work on Walters Road should include the removal of these trees and the re-landscaping of this area to match the existing landscape design in the Bella Vista Drive area. Phase 3 would be done after the opening of Walmart.

Per the original impact fee study it is appropriate to use OSSIP funds for work on Walters Road. It should also be noted that out of the fees that were collected for the building permit for the Walmart construction, \$635,004.00 was deposited into the OSSIP Fund.

The Phase 2 project budget is anticipated to be as follows:

The staff recommendation is to award the contract to MCK Services for the base bid of \$127,110, and to authorize a contingency of \$79,000 as the combined amount to include the change order to add the southbound lanes and for other unforeseen issues. It is also recommended that Council direct staff to move forward with Phase 3. To facilitate these projects staff recommends the transfer from the OSSIP Fund of \$220,000.00 to cover these expenses.

CITY AGENDA ITEM: Council Adoption of Resolution No. 2015-__: Authorizing the City Manager to Negotiate and Execute an Amendment to the Franchise Agreement with Solano Garbage to Provide Citywide Drop-Off Days and Street Sweeping Services.

FISCAL IMPACT: There is no impact to the General Fund. Republic Services DBA Solano Garbage (hereinafter "Solano Garbage") is requesting an increase of \$62,058.96 per year to be passed along to rate payers if the current dump pass program is continued unchanged. This would result in a 2.06% rate increase to commercial and residential customers. All residential customers would see a \$0.61 per month rate increase to cover the increased costs associated with dump passes. At this time, only about 23% of all dump passes issued annually are redeemed.

BACKGROUND: In 1998 the City and Solano Garbage amended the franchise agreement to provide a program whereby customers would be provided two dump passes per year. The original cost of the program was \$0.60 per month. Since 1998, the original \$0.60 per month has been adjusted by the CPI provisions of the franchise agreement, and it now equates to \$0.94 per month. The amendment allowed Solano Garbage to present information to the City prior to March 1st of each year, if it could justify a rate increase to continue to provide this service, but Solano Garbage has not sought to modify the rate to recover its total costs since 1998. Solano Garbage has presented information to the City that would justify an increase of \$0.61 per month to make up the current shortfall of \$62,058 per year, which means that the program currently costs \$1.55 per month to operate.

The City's negotiating team recognized that putting this program on a full-cost-recovery basis would result in an increase in costs to the customers to keep the current dump pass program, or a decrease to the dump pass program. Staff always tries to take a comprehensive look at franchise agreements whenever incremental changes are proposed. In other words, if it is possible "to kill two or more birds with the same stone", staff will try to identify options for the Council to do so.

For example, Council has expressed an interest in enhancing street improvement services. The challenge there is that Gas Tax revenues are generated from a per gallon tax. Not only do these revenues not keep up with inflation, but also these revenues are contracting as vehicles become more fuel efficient. Soon Gas Tax revenues will only be able to support the costs of streetlights, traffic signals, and street sweeping. Eventually street sweeping will also become unaffordable.

Solano Garbage has provided street sweeping services in the City of Fairfield under the current contract. Through a recent change Solano Garbage's new subcontractor, Contract Sweeping Services, provides a compliant cost-efficient option. If Solano Garbage provided street sweeping services to Suisun City, the Gas Tax Funds that the City currently spends on street sweeping could be redirected to street maintenance. The negotiating team's challenge was to figure out how to enhance Solano Garbage services without causing having a negative impact on rates.

STAFF REPORT: It is important to note that while the users of dump passes are very supportive of the service, in reality fewer than one fourth of the dump passes that are mailed out annually are actually used. This equates to about 4,400 coupons per year on average out of the 17,400 per year that are mailed out (8,700 mailed twice per year).

City street sweeping service costs approximately \$144,000 per year and it is staffed by a Senior Maintenance Worker about half time. In addition, the City's street sweeper is in need of replacement at an estimated cost of \$300,000. All of these costs are borne the Streets Division budget, which is funded entirely by Gas Tax revenues. Solano Garbage has offered to sweep our streets for \$140,000 per year. Combining street sweeping services with other Solano Garbage services could take the financial burden of providing street sweeping services off of the City. It would return much needed funds to the Streets Division, release a Senior Maintenance Worker to concentrate on other needed duties such as streets maintenance, eliminate the need for the City to purchase a new street sweeper unit, as well as avoid further ongoing expensive repairs to the sweeper.

One way to enhance Solano Garbage's services without impacting rates would be to use economies of scale to reduce costs. For example, instead of providing passes that allow some customers to haul unwanted materials to that landfill, several Citywide Drop-off Days could be offered where customers could drop off their unwanted materials at a fixed central location in the City. Drop boxes could be provided for trash, green waste, and other recyclables. Solano Garbage could partner with non-profits like The Salvation Army or Mission Solano to collect the reusable items during the Drop-off Days. Electronic equipment and "white goods" (old refrigerators, washers, dryers, etc.) could be collected. This would reduce costs at the landfill, increase the City's landfill diversion rate, reduce individual customer's transportation costs and associated air pollution, and enhance reuse of items "rescued" from the waste stream. The central location could make access easier for some who have difficulty transporting their loads to Potrero Hills Landfill.

The options are discussed in more detail below:

Keep existing dump passes – There would be a Citywide rate increase of 2.06% or \$0.61 per month to keep the existing dump pass program. This would mean that the costs for the program would be borne by all customers, despite the fact that only about 23% of customers actually redeem their dump passes.

- <u>Keep existing dump passes & add street sweeping services</u> The City would benefit from the outsourcing of street sweeping as described above. It would remove the current cost to the City of performing street sweeping internally which is approximately \$144,000 per year. It would result in a rate increase of 5.55% or \$1.64 per month.
- Keep 2000 dump passes, add street sweeping & two Citywide Drop-off Days This option would keep a significant number of dump passes, while adding street sweeping services, as well as two Citywide Drop-off Days per year. It would free up about \$144,000 in Gas Tax revenues to be used for eligible activities such as street maintenance. This would result in a rate increase to all customers, whether they use the dump pass or not, of 1.62% or \$0.48 per month.
- 500 dump passes & three Drop-off Days This option would provide a more convenient and more accessible alternative for customers to get rid of unwanted materials. Instead having two dump passes, customers would three opportunities to get rid of unwanted materials. A total of 500 dump passes would still be available to be used by those in situations that prevent customers from taking advantage of the three Drop-off Days. These special cases could be for such times as when Code Enforcement needs to facilitate correction of a special problem, or when a military resident has an urgent relocation need. Solano Garbage representatives indicated that the City of Fairfield currently receives 200 dump passes per year, all of which are handled and distributed by the Code Enforcement Officers.

In conclusion, staff recommends that the Council consider modifying the existing Franchise Agreement with Solano Garbage to enhance services and avoid a rate increase by directing staff to enter into an amendment to accomplish alternative number four above.

RECOMMENDATION: It is recommended that the City Council adopt Council Resolution No. 2015-__: Authorizing the City Manager to Negotiate and Execute an Amendment to the Franchise Agreement with Solano Garbage to Provide Citywide Drop-Off Days and Street Sweeping Services.

RESOLUTION NO. 2015-___

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SUISUN CITY AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND EXECUTE AN AMENDMENT TO THE FRANCHISE AGREEMENT WITH SOLANO GARBAGE TO PROVIDE CITYWIDE DROP-OFF DAYS AND STREET SWEEPING SERVICES

WHEREAS, in 1998, the City and Solano Garbage (currently Republic Services DBA Solano Garbage) amended the franchise agreement to provide a program whereby customers would be provided two dump passes per year; and

WHEREAS, the amendment allowed Solano Garbage to present information to the City prior to March 1st of each year, if it could justify a rate increase to continue to provide this service; and

WHEREAS, Solano Garbage has presented information to the City that would justify an increase of \$0.61 per month to make up the current shortfall of \$62,058 per year, which means that the program currently costs \$1.55 per month to operate; and

WHEREAS, City street sweeping service costs approximately \$144,000 per year and is funded exclusively from Gas Tax revenues; and

WHEREAS, combining street sweeping services with other Solano Garbage services could take the financial burden of providing street sweeping services off of the City, return much needed funds to the Streets Division, release a Senior Maintenance Worker to concentrate on other needed duties such as streets maintenance, eliminate the need for the City to purchase a new street sweeper unit, as well as avoid further ongoing expensive repairs to the sweeper; and

WHEREAS, providing Citywide Drop-off Days would reduce costs at the landfill, increase the City's landfill diversion rate, reduce individual customer's transportation costs and associated air pollution, and enhance reuse of items "rescued" from the waste stream.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Suisun City does hereby authorize the City Manager to negotiate and execute an amendment to the Franchise Agreement with Solano to provide three Citywide Drop-off Days, Citywide street sweeping services, and 500 dump passes in lieu of the program of providing two dump passes per year to customers.
