NOTICE OF PROPOSED ORDINANCE AND PUBLIC HEARING

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SUISUN CITY, CALIFORNIA, REPEALING AND REPLACING SECTION 18.36.070 OF TITLE 18 OF THE SUISUN CITY CODE AND AMENDING THE WATERFRONT DISTRICT SPECIFIC PLAN, RELATING TO REGULATIONS FOR FRONT, REAR, AND SIDE YARD AREAS OF RESIDENTIAL PROPERTIES

NOTICE IS HEREBY GIVEN THAT the City Council of the City of Suisun City will be considering amendments to Title 18 “Zoning” of the Suisun City Code, as well as the Waterfront District Specific Plan at their regular meeting of Tuesday February 4, 2020 at 6:30pm. The ordinance will include amendments relating to residential front yards and parking provisions. The meeting will take place at the Suisun City Council Chambers, 701 Civic Center Boulevard, Suisun City, CA 94585. All interested parties are invited to attend. The subject ordinance is categorically exempt from the California Environmental Quality Act (“CEQA”) [State CEQA Guidelines Section 15061(b)(3)] as is it can be seen with certainty that there is no possibility that the Project may have a significant effect on the environment. The Suisun City Planning Commission recommended City Council adoption by a vote of 7-0 at their regular meeting of September 24, 2019.

The complete draft ordinance is on file and may be reviewed at the Suisun City Development Services Department at 701 Civic Center Boulevard between 8:00 a.m. and 6:00 p.m., Mondays, Wednesdays and Thursdays and between 8:00 a.m. and 7:00 p.m. on Tuesdays, City Hall is closed on Fridays.
