**Planning Commission**

The Planning Commission meets at 6:30 p.m. on the second and fourth Tuesday of the month in the Council Chambers at Suisun City Hall. The Commission reviews and makes recommendations on the community's General Plan, development applications and policy proposals on both current development, as well as long range plans for future development. On January 18, 2022, the City Council may adopt an Ordinance reducing the number of Planning Commissioners to five (5). The two (2) vacant seats would be eliminated.
