NOTICE IS HEREBY GIVEN that the City of Suisun City is seeking qualified applicants to fill one (1) vacancy on the Suisun City Parks & Recreation Commission and one (1) vacancy on the Suisun City General Tax Oversight Committee. Interested residents are encouraged to apply.

PARKS & RECREATION COMMISSION

The Parks and Recreation Commission is an advisory board to the Recreation Department, Public Works Department and the City Council regarding all matters relating to the leisure services and activities conducted within Suisun City. The Parks and Recreation Commission meets on the first and third Wednesday of each month at 7:00 p.m. (One appointment to fill an unscheduled vacancy, term ending January 2021.)

GENERAL TAX OVERSIGHT COMMITTEE

The General Tax Oversight Committee was required by the adoption of Measure S in the November 8, 2016, General Election. The Committee is charged with monitoring the revenue collected pursuant to the General Transactions and Use Tax Ordinance and reporting on the use of the funds. The Committee will ensure transparency and oversight of the revenue generated by the voter-approved tax. The Committee has five (5) members who are residents and taxpayers of the City of Suisun City. The Committee shall meet at least once per year but may meet more often if deemed necessary. All members shall participate in Brown Act and AB 1234 Ethics training. (One appointment to fill an unscheduled vacancy, term ending April 2020.)

Applicants must be residents of the City of Suisun City during their term of office. Interested residents may apply by submitting an application form to the City Clerk stating qualifications and objectives for desiring to be become a member of the Parks & Recreation Commission or the General Tax Oversight Committee.

Appointees must file a Statement of Economic Interests Form with the City Clerk within thirty (30) days of assuming office as mandated by California State Law and complete required AB 1234 Ethics Training.
