### NOTICE OF PROPOSED ORDINANCE AND PUBLIC HEARING

#### **AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SUISUN CITY, CALIFORNIA, AMENDING TITLE 18 “ZONING” AND THE WATERFRONT DISTRICT SPECIFIC PLAN REGARDING RESIDENTIAL FRONT YARD TREATMENTS AND RESIDENTIAL PARKING PROVISIONS**

**NOTICE IS HEREBY GIVEN THAT** the Planning Commission of Suisun City will be considering making a recommendation to the City Council regarding amendments to Title 18 “Zoning” of the Suisun City Code, as well as the Waterfront District Specific Plan at their special meeting of Tuesday December 18, 2018 at 7pm. The ordinance will include amendments to relating to residential front yard treatments and parking provisions. The meeting will take place at the Suisun City Council Chambers, 701 Civic Center Boulevard, Suisun City, CA 94585. All interested parties are invited to attend. The subject ordinance is categorically exempt from the California Environmental Quality Act (“CEQA”) [State CEQA Guidelines Section 15061(b)(3)] as is it can be seen with certainty that there is no possibility that the Project may have a significant effect on the environment.

The complete draft ordinance is on file and may be reviewed at the Suisun City Development Services Department at 701 Civic Center Boulevard between 8:00 a.m. and 6:00 p.m., Mondays, Wednesdays and Thursdays and between 8:00 a.m. and 7:00 p.m. on Tuesdays, City Hall is closed on Fridays.
